INTERGOVERNMENTAL AGREEMENT FOR JOINT USE OF  
SMALL WORKS ROSTER AND VENDOR LIST  
(RCW Chapter 39.34)

This Agreement is made and entered into by and between Fire Protection District 4, hereinafter called AGENCY and Stevens County, a municipal corporation of the State of Washington, hereinafter called COUNTY.

- a. COUNTY SHALL maintain a Small Works Roster and Vendor List in accordance with RCW 39.04 to the best of its ability. COUNTY shall be the lead entity responsible for implementing the provisions of RCW 39.04.155. COUNTY makes no representation or warranty as to the accuracy or completeness of its roster or list and AGENCY shall conduct its own review of the COUNTY'S policies and procedures prior to use of said roster or list.
- b. AGENCY SHALL be allowed to use the COUNTY Small Works Roster for solicitation of bids for Building Construction and Maintenance, in accordance with RCW 39.04.155 (3), and the COUNTY Vendor List for award of contracts for the purchase of any materials, equipment, supplies, or services pursuant to RCW 39.04.190. Use by AGENCY of COUNTY'S lists signifies acceptance of the legality and completeness of COUNTY roster or list.
- c. Neither party assumes any responsibility or liability arising from the other party's use of the Small Works Roster or Vendor List to award contracts pursuant to RCW Chapter 39.04, and each party shall hold the other party harmless from and indemnify the other party against any and all claims which may arise from the use of the Small Works Roster by that party.
- d. AGENCY shall publish notice as required by law of its intent to use the COUNTY Small Works Roster and COUNTY Vendor List.
- e. This Agreement shall be reviewed by the respective parties on an annual basis to facilitate amendments to be made as necessary.
- f. This Agreement shall be effective as of the last date written below.
- g. This Agreement may be cancelled at any time upon 15 days written notice to the other party.
