

STEVENS COUNTY ORDINANCE NO. 6-2009  
REPEALING ORDINANCE NO. 2007-02 AS AMENDED  
AND DESIGNATING ROADS FOR OFF HIGHWAY VEHICLE USE

The purpose of this ordinance is to regulate the operation of nonhighway vehicles on designated county roads and rights of way.

Section 1. Ordinance 2007-02 as amended is hereby repealed and replaced and superseded by this ordinance.

Section 2. All persons traveling upon or using designated county roads or rights of way for the operation of nonhighway vehicles shall strictly comply with all provisions of Chapter 46.09 RCW and any and all other applicable provisions of local, state and federal laws.

Section 2. Nonhighway vehicles, as defined in Chapter 46.09 RCW, may use the county roads and rights of way specified in Exhibit 1, attached hereto and incorporated herein.
