AUTHORIZING THE AUDITOR TO  
REPORT ADDITIONAL HOURS FOR  
THE CORONER FOR YEARS 2003,  
2004, 2005 AND 2006

WHEREAS, the Board finds that when Patti Hancock was first elected coroner, the Board set her salary as an elected official as half-time for the years 2003, 2004, 2005 and 2006; and

WHEREAS, the Board finds the Board recognized that the office of coroner is full time and made an adjustment for the coroner salary as full time beginning in 2007 through the present; and

WHEREAS, the Board finds the retirement credit service for Coroner Patti Hancock should be recognized as full time for the years 2003, 2004, 2005 and 2006 so as to accurately reflect her full time service for those years;


NOW, THEREFORE, IT IS HEREBY RESOLVED AND ORDERED that the Stevens County Auditor is authorized and requested to report an additional nine hours per month to the Washington State Department of Retirement Services for the years 2003, 2004, 2005 and 2006 for Coroner Patti Hancock and/or take such other steps as are necessary to reflect her full time service for those years; PROVIDED, Coroner Patti Hancock agrees no additional compensation nor monies of any nature shall be paid or accrued for any of those months. 

MEMORANDUM OF AGREEMENT  
REGARDING FULL TIME STATUS  
OF CORONER PATTI HANCOCK  
FOR YEARS 2003, 2004, 2005 AND 2006

STEVENS COUNTY and CORONER PATTI HANCOCK, agree as follows:

1. For the years 2003, 2004, 2005 and 2006, the County established the position of Coroner as a half-time position and paid her accordingly and reported her retirement service credits accordingly.
2. In 2007, the County recognized the position of Coroner was actually a full-time position and the Coroner should be paid accordingly and had her retirement service credits reported accordingly through the present.
3. The County recognizes the office and duties of Coroner in years 2003, 2004, 2005 and 2006 should have been reported as full time service credits for those years.
4. The County will report nine additional hours of service credit to the Department of Retirement Services per month for the years 2003, 2004, 2005 and 2006 for Coroner Patti Hancock.
5. No additional compensation nor monies nor benefits of any kind or nature shall be paid to Coroner Patti Hancock for these years.
