
WHEREAS, the Board finds these taxes are not collectible and the Treasurer should be allowed to petition the court to extinguish the liens;



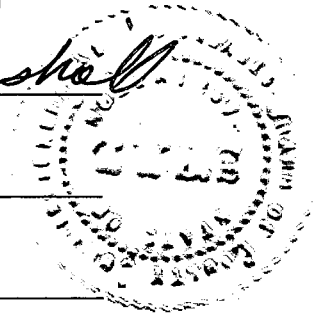
