SETTING THE AMOUNTS OF CERTAIN SHERIFF'S FEES TO COVER THE COSTS OF ADMINISTRATION AND OPERATION

WHEREAS, the Board finds the Sheriff is required to collect certain fees for official services as provided in RCW 36.18.040; and

WHEREAS, the Board finds that certain fees currently being collected by the Sheriff do not cover the costs of administration and operation; and

WHEREAS, the Board finds RCW 36.18.040 authorizes the county legislative authority to set the amounts of fees that shall be collected to cover the costs of administration and operation;

NOW, THEREFORE, IT IS HEREBY RESOLVED AND ORDERED that the Sheriff shall collect the fees specified in Exhibit A, attached hereto and incorporated herein., to cover the costs of administration and operation:
