WHEREAS, the attached 2014 rates consider the actual full cost of operating and maintaining the equipment, and will include an appropriate increase toward the cost of future equipment replacement.

NOW, THEREFORE, BE IT RESOLVED by the Board of Stevens County Commissioners that the revised Equipment Rental Rate schedule as attached hereto is hereby adopted, will be effective March 1, 2014, and shall supersede all such prior Equipment Rental Rate schedules.
