SETTING A HEARING DATE TO CONSIDER A  
PROPOSED INTERIM OFFICIAL CONTROL  
RESTRICTING THE SITING and DEVELOPMENT OF  
MARIJUANA PRODUCTION FACILITIES, MARIJUANA  
PROCESSING FACILITIES and MARIJUANA RETAIL  
SALES FACILITIES FROM CERTAIN ZONES WITHIN THE  
UNINCORPORATED BOUNDARIES OF STEVENS  
COUNTY AND REPEALING RESOLUTION #57-2014

WHEREAS, the Board finds that Initiative 502 was passed into law by the voters in the 2012 November general election; and

WHEREAS, the Board finds that a moratorium on the production, processing and retail sale of marijuana was adopted on November 5, 2013 in all zones of unincorporated Stevens County pursuant to Resolution #59-2013; and

WHEREAS, the Board finds that the moratorium has since been continued twice (Resolution #25-2014 and Resolution #57-2014) and will expire on April 20, 2015; and

WHEREAS, the Board finds that a proposal to consider an interim official control in limited zones within unincorporated Stevens County should be considered and a public hearing held.

NOW, THEREFORE, IT IS HEREBY RESOLVED AND ORDERED:

1. A hearing on the proposal to adopt an interim official control restricting the siting and development of marijuana production facilities, marijuana processing facilities and marijuana retail sales facilities from certain zones within the unincorporated boundaries of Stevens County and repealing Resolution #57-2014 shall be held on **Monday, April 13, 2015 at 2:00 p.m.** in the Commissioners Office; 230 E. Birch Avenue; Colville, Washington.
2. The Clerk of the Board is authorized and directed to give notice of the hearing.

Passed by the Board of Stevens County Commissioners meeting in regular session at Colville, Washington, by the following vote, then signed by its membership and attested to by its Clerk in authorization of such passage the 9<sup>th</sup> day of March, 2015.
