SETTING A HEARING DATE TO CONSIDER A
PROPOSAL TO ADOPT INTERIM ZONING CONTROL
FOR THE SITING and DEVELOPMENT OF
RECREATIONAL AND MEDICAL MARIJUANA
FACILITIES WITHIN CERTAIN ZONES IN THE
UNINCORPORATED BOUNDARIES OF STEVENS
COUNTY

WHEREAS, the Board finds that Initiative 502 was passed into law by the voters in the 2012 November general election; and

WHEREAS, the Board finds that a moratorium on the production, processing and retail sale of marijuana was adopted on November 5, 2013 in all zones of unincorporated Stevens County pursuant to Resolution #59-2013; and

WHEREAS, the Board finds that the moratorium has since been continued and/or amended four times (see Resolution #25-2014, Resolution #57-2014, Resolution #38-2015 and Resolution #63-2015) and will expire on February 24, 2016; and

WHEREAS, the Board finds that a proposal to adopt interim zoning control in limited zones within unincorporated Stevens County should be considered and a public hearing held; and

## NOW, THEREFORE, IT IS HEREBY RESOLVED AND ORDERED:

- A hearing on the proposal to adopt interim zoning control for the siting and development of recreational and medical marijuana production facilities, processing facilities and retail sales facilities within certain zones within the unincorporated boundaries of Stevens County and repealing Resolution #63-2015 shall be held on Tuesday, January 12, 2016 at 3:00 p.m. in the Commissioners Office; 230 E. Birch Avenue; Colville, Washington.
- 2. The Clerk of the Board is authorized and directed to give notice of the hearing.
