AUTHORIZING THE TREASURER
TO PETITION THE SUPERIOR
COURT TO EXTINGUISH CERTAIN
PERSONAL PROPERTY TAX LIENS

WHEREAS, the Board finds the Treasurer has requested the Board to authorize her to petition the Superior Court to extinguish certain uncollectible personal property taxes pursuant to the provisions of RCW 84.56.270; and

WHEREAS, the Board finds these taxes are not collectible and the Treasurer should be allowed to petition the court to extinguish the liens;

NOW, THEREFORE, IT IS HEREBY RESOLVED AND ORDERED that the Stevens County Treasurer is authorized to petition the Superior Court to extinguish those personal property tax liens for the parcels contained in Exhibit 1 attached hereto and incorporated herein.
