IN THE MATTER of Resolution of the Board of County Commissioners of Stevens County, Washington, declaring the intention to vacate and abandon the following described portion of County Easement:

That portion of Cedar Street lying adjacent to and abutting Block 6; and, that portion Third Street lying adjacent to and abutting Block 6; and, all of the alley lying within Block 6, all in MARBLE, according to plat thereof recorded September 14, 1920, in Book B of Plats, page 32 and as amended by Stipulated Findings and Order Regarding Plat, recorded January 31, 2012, under Auditor's File Number 2012 0000852.

This matter coming on regularly for hearing on the 29th day of August, 2017, at 11:00 a.m. it appearing that notice of said hearing has been given for the time and in the manner provided by law, it further appearing that the portion of roads and alley described herein is no longer necessary as a public easement; that the vacation will be a benefit to Stevens County, and there being no reasonable evidence presented in opposition to the vacation and abandonment thereof, and the Board being fully advised in the premises.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Stevens County, Washington, that the strip of non-built roads and alley described above is hereby vacated and abandoned as County Easements.

Passed by the Board of Stevens County Commissioners meeting in regular session at Colville, Washington, by the following vote, then signed by its membership and attested to by its Clerk in authorization of such passage the 29th day of August, 2017.
