Resolution No. 14-2018

SETTING A HEARING REGARDING A
PROPOSED ANNEXATION TO EXTEND
THE BOUNDARIES OF STEVENS
COUNTY FIRE DISTRICT NO. 13

WHEREAS, the Commissioners of Stevens County Fire District No. 13 submitted Resolution No. 01-2018 to the Stevens County Auditor requesting annexation of certain territory; AND

WHEREAS, pursuant to the provisions of RCW 52.04.011(1), the Stevens County Auditor has determined that the petition submitted had 53 approved signatures and meets and exceeds the required fifteen percent (15%) which is 38 signatures and is considered to be sufficient to be approved in accordance with RCW 52.04.011(1); AND

WHEREAS, there was an insufficient number of signatures to avoid placing this proposed annexation on the ballot; AND

WHEREAS, the Auditor has verified that the area requested to be annexed meets the necessary requirement for annexation; AND

WHEREAS, the Auditor presented these details to the Board of County Commissioners of Stevens County, Washington, on February 13, 2018; AND

WHEREAS, the Board finds that per the requirements of RCW 52.04.011 and 52.02.040, a public hearing must be held by the county legislative authority of the county.

NOW, THEREFORE, IT IS HEREBY RESOLVED AND ORDERED by the Board of Stevens County Commissioners that pursuant to RCW 52.04.011 and 52.02.040 a public hearing shall be held on **Monday, March 19, 2018, at 3:30 p.m.** to consider the proposal from Stevens County Fire District No. 13 for a ballot initiative to extend its boundaries to include currently unprotected properties along the Williams Lake Road corridor south to Gillette Road and include unprotected properties along China Creek Road and along Highway 25 south to abut the boundary of Stevens County Fire District 6 legally described as follows: T38 R38 S34; T37 R38 S25; T37 R38 S28 less parcels in FD 06; T37 R39 S18 and S19 less parcels already in the district; T37 R39 S30, S31, S32; T36 R39 S05 and 06; T36 R39 S07 E2 less S2 SE4 and T36 R39 S08 All properties North of Gillette Road; and T36 R39 S09 less parcels 2287000, 2287900, 2288200 and 2288050.

Passed by the Board of Stevens County Commissioners meeting in regular session at Colville, Washington, by the following vote, then signed by its membership and attested to by its Clerk in authorization of such passage the 20th day of February, 2018.


